The Cheshire Fair is part of the New Hampshire 4-H Program. Standard 4-H conduct is expected for the entire time that a 4-Her is on the fairgrounds. Parents are expected to supervise their children or to obtain a signature from the adult agreeing to provide supervision. Participation in the Cheshire Fair is dependent on your agreement to the following expectations:

- ➤ 4-H members shall show respect for the property and facilities used during the fair, and they and their family will assume financial responsibility for any damage they cause.
- ➤ 4-H members and their parents shall conduct themselves at all times in a manner appropriate to the standards and image of the 4-H program, they will refrain from criticizing or interfering with the judge, show management or other exhibitors. Problems will be resolved using appropriate channels.
- ➤ 4-H members shall not use or possess alcoholic beverages, tobacco, or controlled drugs.
- All the animals to be exhibited at Cheshire Fair have been vaccinated for Rabies.
- All 4-Hers will be responsible for caring for their own animals. 4-Hers will be prepared to show proof of ownership, documentation of age, health and/or other requirements.
- Animals are shown at the risk of the 4-H owner or lessor, any damages to person(s) or property are the legal and financial responsibility of the 4-H member who owns or leases the animal and their family.
- ➤ 4-Hers are the sole responsibility of their parent or guardian for the duration of the Cheshire Fair.

We have read and discussed the above expectations and hereby agree to accept them. I/We have read and understand the basic 4-H rules and rules pertaining to Animal Shows we are involved with, in the 4-H Cheshire Fair Book. I/We understand that failure to comply shall result in the 4-H member being expelled from the Cheshire Fair and premiums being withheld.

## Fire Safety/Regulations Policy

All Horse Stables, Cattle Stalls, and Barns

Due to Fire Safety/Regulations, there shall be **No Sleeping** in any of the above-mentioned areas. Only preapproved supervisors will be allowed to monitor barns at night.

Absolutely **No Smoking** is allowed in the stables, stalls, or barns.

Absolutely **No Appliances\*** are allowed in the stables, stalls, or barns at any time during the fair. This includes, but is not limited to:

- Refrigerators
- Toasters/Toaster Ovens
- Coffee Makers
- Crockpots
- Hot Plates

If any appliance(s) or item(s) is deemed to be a safety issue or fire hazard, and is found in a restricted area, the Cheshire Fair Staff and/or Security has the right to remove it without notice.
