

Cheshire Fair Exhibitor Camping Gate 3 2023 Rules / Regulations

- All Campers and tents must check in with the Camping Supervisor upon arrival. You will be directed to an available space. No reserving spaces. You will be required to move your camper or tent if you park in an unauthorized space. All campers and tents must display camper/tent permits at all times during the fair. Permits will be verified and are used for emergency purposes. Early arrivals may not hookup to water/electricity unless you are staying on the grounds. No sleeping in any of the barns/stalls. Only preapproved supervisors will be allowed to monitor barns overnight.
- No AC Units allowed.
- You are required to keep a clear 12' area between the rows of campers for emergency purposes. All campers must be parked tow to bumper facing in the same direction.
- All exhibitors are required to complete an Exhibitor Camping & Passes Form to receive passes and a Gate 3 vehicle pass. <u>Day of arrival is required on form</u>. Incomplete forms will not be processed.
- All Exhibitors must have a wristband or pass to enter Gate 3. <u>All Non-Exhibitors</u> are required to purchase passes through main entrance only (Gate 5). No exceptions.
- Due to limited space -One (1) Gate 3 Vehicle pass per 4-H Family allowed. <u>All vehicles are required to park in the upper lot above the Draft Horse Barn</u>. Shuttle golf cart will be available at Gate 3 for assistance. *Non-Exhibitors/Visitors must park at Main Gate. No exceptions.
- You will receive a transporter vehicle pass if requested on the Exhibitor Camping & Passes Form. <u>All transporter vehicles and trailers must park in upper lot.</u> Violators will be towed at owner's expense.
- ➤ 4-H members working in the 4-H Food Booth must have a pass to enter Gate 3. Food Booth Pass Request Form available at the 4-H Office. Drivers cannot park at Gate 3. 10-minute limit parking for drop offs and pick ups.
- All cattle must arrive no later than 7 AM Thursday August 3th. Other livestock, please see rules for specific arrival and departure times. No vehicles allowed in barn areas after 8:00 AM daily.
- Please help to keep all areas clean, including around the wash rack area. Always clean up after your animal(s). *Remember spectators enjoy walking around to view the animals.

For everyone's safety we ask that there are:

- No Open Fires
- No Alcoholic Beverages
- No Dogs
- No Smoking near Barns/Stalls
- No Sleeping in any Barns/Stalls
- No Appliances in any Barn/Stalls
- No Vehicles in near Barn/Stalls after 8:00 AM
